## **Resolutions of the 33<sup>rd</sup> Annual General Meeting of Shareholders**

SB Technology Corp. notifies the shareholders of SB Technology Corp. of the reports made and resolutions adopted at the 33<sup>rd</sup> Annual General Meeting of Shareholders as described below.

### **Matters to be reported:**

1. Business Report, Consolidated Financial Statements for the 33<sup>rd</sup> fiscal year ended March 31, 2021 (April 1, 2020 to March 31, 2021) and results of audits by the Independent Auditor and the Audit & Supervisory Board of the Consolidated Financial Statements.
2. Financial Statements for the fiscal year ended March 31, 2021 (April 1, 2020 to March 31, 2021).

The particulars of the above were reported.

### **Matters to be resolved:**

#### Proposal 1: Appropriation of Surplus

This proposal was approved and adopted as proposed. It was decided to pay the year-end dividend of 25 yen per share for the fiscal year.

#### Proposal 2: Election of Six Board Directors

The proposal was approved and adopted as proposed. Shinichi Ata, Mitsuhiro Sato, Masaaki Okazaki, Kimihiko Kaneko, Shigeo Suzuki and Yoshie Munakata were elected and each of them assumed the office.

Mr. Shinichi Ata was elected as Representative Director at the Board Directors' meeting held following the conclusion of the Annual General Meeting of Shareholders, and he assumed the office.
