**Notice Concerning Change of Corporate Name and  
Partial Amendments to Articles of Incorporation**

The Company announced today that it has decided to propose a change to its trade name and partial amendments to the Articles of Incorporation at the 31st Ordinary General Meeting of Shareholders scheduled for June 17, 2019. Details are as follows.

1. Change of corporate name

(1) Reason for change

The Company will change its corporate name to “SB Technology Corp.” with the aim of enhancing its autonomous management and building a group that has stronger strategic synergies with its parent company, SoftBank Corp., in promoting the group strategy of SoftBank group.

Under its corporate philosophy “Information Revolution — Happiness for everyone,” the SoftBank Group Corp. aims to become a corporate group that maximizes its company value and provides the technologies and services most needed by people around the world. The Company, however, aims to “generate new values to the world by leading technologies and creativeness with diverse work styles and opportunity-full culture,” under its own philosophy “Information Revolution — Happiness for everyone ~ Technologies Design the Future ~” based on the Group philosophy. Further, the Company will continue to create innovative solutions and unique services to face the challenges of expanding its operations and increasing its corporate value.

2. Partial amendments to the Articles of Incorporation

The Company will amend Article 1 of the current Articles of Incorporation in order to change the corporate name as mentioned in “1. Change of corporate name” above.
